Overview of the Disposal of the Company's Treasury Shares

The closing price of the common shares of the Company on July 4, 2024 (the business day immediately preceding the date of resolution by the Board of Directors) on the Standard Market of the Tokyo Stock Exchange of 10,920 yen is used as the fair value of the disposal price, and the total amount of disposal is 74,747,400 yen, which is calculated by multiplying the disposal price by the number of shares subject to disposal.
