Notice regarding Revisions of Year-End Dividend Forecast

C. Uyemura & Co., Ltd. (hereinafter “the Company”) hereby announces that at the Board of Directors meeting held today (November 10, 2025), it has resolved the revision of its dividend forecast for the fiscal year ending on March 31, 2026 as below.

1. Reason for the revision of the dividend forecast

The Company views the return of profits to its shareholders as an essential management issue. The Company's basic policy is maintaining stable dividends in line with our business performance.

As a result of comprehensive consideration of the business performance and financial position in the fiscal year ending on March 31, 2026, the Company plans to revise the year-end dividend forecast from the previous forecast of 230 yen to 280 yen, an increase of 50 yen per share, pursuant to its basic policy.
